FEE REFUND POLICY 2024.25

In accordance with UGC Notification No. D.O. No. F-2-7112022 (CPP-II) (C-114546) dated 12th June 2024, the Dr. P. A. Inamdar University, Pune, has implemented the following fee refund policy for the Academic Year 2024-25:

1. The last date of admission to any of the UG and PG programs of the Dr. P. A. Inamdar University, Pune is 30th September 2024.
2. Refund Policy:
 - a) This policy shall apply to all undergraduate and postgraduate programs run by the Dr. P. A. Inamdar University, Pune.
 - b) The provisions contained in the policy shall come into force with immediate effect and shall have regulatory force to the extent as well as future grievances over issues and matters covered herein.
3. Withdrawal Request:

Student must submit a written application to withdraw from their enrolled program, including a clear explanation of their reasons for withdrawal
4. Fee Refund:

Category	Percentage of Refund of fees*	The point in time when notice of withdrawal of admission is received in the university
(1)	100%	15 days or more before the formally notified last date of admission
(2)	90%	Less than 15 days before the last date of admission, 31 st October 2024
(3)	80%	15 days or less after the last date of Admission, 31 st October 2024
(4)	50%	30 days or less, but more than 15 days after formally Notified the last date of admission as 31 st October 2024
(5)	00%	More than 30 days after the last notified date of admission, 31 st October 2024

5. The UGC has notified the Redressal of Grievances of Students Regulations, 2023, wherein "delay in or denial of the refund of fees due to a student who withdraws admission within the time mentioned in the prospectus subject to guidelines if any issued by the Commission from time to time" has been defined as one of the grievances. In case a student is dissatisfied or has a grievance concerning a fee refund, he/she may approach the Grievance Redressal Cell of the Dr. P. A. Inamdar University, Pune.
